Ken Brunette gave her application. Theresa Chenier read data of research she performed on dates of Williams at previously attended PC meetings .

Board Comments: Jack Penegor thanked Ad Hoc Committee. ETPC needs to set a time frame for Ad Hoc committee report review. Per Jack Penegor & Atty Burkhart; no vote tonight but suggested to hold a Special Meeting to establish dates after ETPC has time to review report.

Dean VanLoon motioned there is old information on website that should be deleted. Theresa Chenier, second. All Favor. Theresa Chenier motioned to put Ad Hoc report on website. Dean VanLoon second. All Favor.

Dean VanLoon motioned to vote to hold Special Meeting Tuesday March 17, 2020 at Town Hall in Flat Rock to discuss meeting scheduling for Ad Hoc committee review report. Barry King, second. Penegor-Yes Chenier-Yes Rymko-Yes, King-Yes VanLoon-Yes Fleury-No. Passes with **5 Yes** votes **1 No** vote

Barry King confirmed previous postings of Planning Commission meetings were all done legally

and properly.

New Business: Theresa Chenier presented options for committee members to obtain training. MTA has conferences, webinars, on line training and literature available. There is a cost for the training. Linda Robitaille commented she would bring it up at township budget meeting for decision process.
