NEW BUSSINESS: Mead Rod and Gun Club has expanded the pistol range. Did they follow all protocol? No one knows of any permit requests. They are shooting within 500 feet of the river. There is also a road that runs down the side of the range. This road is used by UPPCO as it goes down to the dam. The public is allowed to fish at the dam location also. There is no berms or anything to protect anyone on that road. They are in violation of current zoning. Would like a cease and desist order given to them, for the use of the shooting range expansion of the Mead Rod and Gun Club as it violates noise and zoning ordinance. A motion by Barry King to take this to the Escanaba Township Board for a cease and desist order be given to the Mead Rod and Gun club an it violates noise and zoning ordinance. Seconded by Cliff Barron. A vote was taken and all commission member voted yes.

OLD BUSINESS: Solar ordinance. A Copy was given to the commission to read over and see if there are any corrections. This will be given to the Escanaba Township Board after the committee goes over the ordinance to see if any changes need to be made

Reno Creek. Jack Penegor called the DNR. But has had no return call. There is state land there and the creek 40 to 50 years ago had good trout fishing. We are going to see if the DNR can stock Reno Creek again.
